In response to the harsh economic impact that COVID-19 has had on residents, the Rialto Rental Assistance Program will offer one-time rental assistance up to \$4,800 (\$800 per month) to help renters in the City of Rialto. Previously approved applicants can re-apply for any eligible balance up to a total maximum amount allowed, stated above. Financial assistance will be offered to low/moderate income households per Housing and Urban Development (HUD) guidelines who rent/own in the City and have experienced loss of income due to the COVID-19 pandemic. The grant program is made possible with federal Community Development Block Grant CARES Act (CDBG-CV) funds from the Department of Housing and Urban Development (HUD), therefore residents must meet all requirements to be eligible for the program. Applications are processed on a first come, first served basis until all funding is allocated (No Deadline Date). **Payments will be made directly to landlords/mortgage provider/mortgage servicer. Mortgage payments are for the monthly amount of principal and interest only.**
